### **West Texas Lighthouse for the Blind: Providing stability one job at a time**

The West Texas Lighthouse for the Blind in San Angelo, Texas is dedicated to providing life-changing job opportunities to blind and visually impaired individuals.

The Lighthouse, a Community Rehabilitation Program (CRP) in the *WorksWonders* Program, is a non-profit organization that offers on the job training, upward mobility and advocacy for blind and visually impaired individuals. Since 1963, its mission has been to assist people in building their independence through skills training, education and employment opportunities that encourage individuals to be involved in the community. Over 90% of the Lighthouse's direct employees are legally blind, and the Lighthouse is proud to not only provide opportunities to these individuals but provide meaningful employment that offers competitive pay and benefits.

Dave Wells, chief executive officer of the Lighthouse, is honored to lead the organization and change lives one job at a time. He recognizes that the Lighthouse makes a positive difference in his community and is grateful to have hard-working and dedicated employees.

“We are the only employer in all of West Texas that focuses on providing jobs to people that are blind or visually impaired, and a lot of our employees would not have jobs if it wasn't for us,” said

Wells. “We have people that work very hard and we have very smart employees that raise all our intelligence levels and teach us things every day.”

Mark Dudley has been employed by the Lighthouse for over seven years and says he is grateful that his job has given him the opportunity to provide for himself. “This job means independence and being self-sufficient,” said Dudley. “I like knowing that I have a job every day and that I don't have to worry about financial restrictions.”

Dudley feels fortunate to have a job at the Lighthouse and truly enjoys the work he does. “I do quality work because my work is not only a reflection of me, but also of the Lighthouse,” said Dudley.

As for the Lighthouse, Wells is thankful for its partnership with WorkQuest and is glad to continue to provide meaningful job opportunities for blind and visually impaired individuals through the *WorksWonders* program.

“Our partnership with WorkQuest is very important to us,” said Wells. “We are happy to be able to provide our employees with a way to be financially independent through meaningful jobs that are possible because of the *WorksWonders* program.”

On Monday, May 29, 2023, the Texas Legislature ended the 140-day Regular Session. That evening, Governor Greg Abbott called a Special Session with the scope limited to property tax relief and border security. WorkQuest continued to monitor legislation that could have potentially affected the *WorksWonders* Program and its stakeholders. # WorkQuest 2023 CRP Compliance & Training Seminars

WorkQuest is excited to announce the 2023 Community Rehabilitation Program (CRP) Compliance and Training Seminars line up. These trainings provide CRPs with important information about participation in the *WorksWonders* Program, governmental contracting practices, and procurement procedures and laws. The seminars also provide an opportunity for CRPs to ask questions of the Texas Workforce Commission (TWC) and WorkQuest staff. TWC and WorkQuest strongly encourage all certified CRPs to send a representative to attend a training seminar, or participate in the training webinar, so that they do not miss out on important information that is needed to complete TWC-required documents and other Program initiatives.

Each seminar will include a morning session that outlines the Program compliance requirements, reviews the Program rules and helps attendees better understand the process of contracting through the Program. WorkQuest staff will also provide instruction on necessary processes like performing person-centered planning and obtaining compliant disability documentation. After lunch, which will be provided by WorkQuest, there will be an afternoon session led by industry expert Betsy Furler, founder of For All Abilities, where she will provide valuable insights on transitioning employees into competitive integrated employment (CIE).
